1) THE FOLLOWING RESOLUTION WAS OFFERED BY SUPERVISOR KEEM, WHO MOVED ITS ADOPTION, SECONDED BY COUNCILMEMBER MAJCHRZAK, TO WIT:

WHEREAS Bids were opened for the Right-of-Way Lawn Restoration project on May 12, 2015, and

WHEREAS this project will consist of the restoration of lawn areas along Town Right-of-Way, in three separate areas, as delineated on the attached map. These areas are the most severely damaged from the Winter Storm Snowfall removal work, and

WHEREAS The Engineering Department reviewed the prices of the one bid received. The bidder's base bid of \$42,000 is slightly above the Engineer's estimate of \$40,000 for the project, and

WHEREAS the low bidder for this project was Birch Grove Landscaping, and

WHEREAS the company has successfully completed various similar projects in the past including Chestnut Village Trail System and Birdsong Park Trail Project for the Town of Orchard Park. Birch Grove Landscaping has been found to have the qualifications and experience to perform this work adequately,

NOW, THEREFORE, be it

RESOLVED that Town Board does hereby award the contract for the Right-of-Way Lawn Restoration Project to the lowest responsible bidder, Birch Grove Landscaping, 11736 Big Tree Road, East Aurora, New York 14052 in an amount not to exceed \$42,000, as recommended by the Town Engineer.

2) THE FOLLOWING RESOLUTION WAS OFFERED BY COUNCILMEMBER SHERRY, WHO MOVED ITS ADOPTION, SECONDED BY COUNCILMEMBER MAJCHRZAK, TO WIT:

WHEREAS, the Town of Orchard Park did hereby receive and opened bids for the Town Brush Pickup on May 13, 2015

NOW, THEREFORE, be it

RESOLVED, that the Town Board does hereby award the Bid for the Town of Orchard Park Pickup to Buffalo and Orchard Park Topsoil they being the lowest bidder thereof for a three year contract as follows: for the Year 2015 - \$130,000.00, for the Year 2016 - \$135,000.00 and for the Year 2017-

\$140,000.00.


Councilmember Sherry recused himself from this vote as he knows the owner.
